
SCCW ACTIVITIES HIGHLIGHTS:

CCW MID-YEAR MEETING HIGHLIGHTS: STORY BY HEIDY CARVER

Heidy Carver, Sharon Erickson, Cheryl Foster, Melanie Fowle, Holli Murphy, & Michele Murphy attended the State CCW meeting at the Lion's Gate Hotel in Sacramento's McClellan Park on June 22-24th. There was a Welcome Reception Wednesday evening that was well attended. On Thursday morning, there was an Informational Forum held at the same time as the CCW Workshop. I attended the Informational Workshop & everyone else attended the CCW Workshop.

The Informational Workshop was attended by approximately 40 people. Dr. Dennis Wilson, an analyst with the California State Veterinary office, gave an update on antibiotics used in as feed additives & SB 27. The requirement to have a Veterinary approved Feed Directive (VFD) in order to use certain antibiotics to treat sick animals begins January 1, 2018. The beef cattle, dairy cattle, poultry, & swine industries are impacted. It also covers antibiotics administered by injections and boluses. Also using antibiotics as a preventative will be stricter. Monitoring in California was supposed to start in 2016, but currently there is no funding available. It will cost \$1.5 million to employ 8 people to do the monitoring and another \$1.5 million for full implementation.



Next Dr. Dennis Hermesch from Elanco Pharmaceuticals spoke about how the VFD includes 80-90% of antibiotics available for use. He stated that the VFD was created as a result of consumer concern & desire to have safe food to eat. Vaccines are still okay to use and do not require a VFD. Elanco recommends using vaccines that are oil based. Promoted their foot rot vaccine that is 60-90% effective with 2 shots.

The next topic was SB 88 which requires monthly monitoring & annual reporting of water right usage. Speakers were Kathy Mrowka from Enforcement Division of Dept. of Water Resources (DWR) & Nathan Weaver Legal counsel for DWR. Monthly monitoring using a DWR approved method & online annual reporting begins in 2017. When in a drought, DWR can ask for monthly reporting. DWR is trying to be more transparent & have a more accurate accounting for the



water used within the state. All water usage reported to the State is public record for anyone to access. DWR is currently watching the Scott River Watershed using the USGS gauges and are considering issuing curtailment letters to Junior Water Right Holders that they will be shut off soon. The US Forest Service water right on Scott River is a senior water right that is used for public trust and is to remain instream for fish. DWR is in charge of the watershed since it is not under any watermaster service. Measuring requirements apply to any water right or if more than one water right serves same place of use that is more than 10 acre feet annually. The measuring

method used must be certified by a California registered professional engineering firm, a licensed contractor who is a well driller or pump installer for water rights greater than 100 acre feet annually. Measuring devices must be 85-90% accurate. Staff gauges & weirs are the most common measuring types. After 2020, many larger diverters (greater than 30 cfs) will be required to use real time telemetry data measuring methods. DWR is currently developing Measuring Methods Plans to simplify the process for multiple water right holders that use the same diversion ditch so that water reporting is accurate. The plan must be submitted every 5 yrs. DWR wouldn't give a clear answer to questions regarding the cost and the fees & permits needed for water right holders to implement the above requirements.

The next speakers were Craig Weaver from CHP Basic Inspection Terminal (BIT) program & Jaime Sanchez CHP BIT Enforcement Officer. As of January 1, 2016, BIT inspections will be done on a performance basis due to Federal Dept. of Transportation regulations. This means that after a new vehicle has had its initial inspection when first put in the program,

the company will not be inspected if the performance score remains low. There are a few vehicle codes that affect agriculture: a pickup with a gross vehicle weight rating of 10,001 lbs., or towing a trailer that when combined with the pickup, the length is over 40 ft., are required to be registered with BIT program. Also a pickup that has had the original box bed removed & any other type of bed installed is subject to BIT program & a motor carrier permit. The driver must have a commercial driver's license & go through weigh scales.



The final speaker was Dr. Michael Anderson DWR

Climatologist. He spoke on the recent weather trends and current drought conditions. In our most recent drought (2012-2015) the state has only received 25% of its 50 yr. average of moisture. For 2016, the state is at 86% of average moisture & hoping for another wet winter. Predicting the weather is a challenge even with the best scientific models.

On Friday morning, the Board of Directors Meeting was held. Approximately 50 women attended & most units were represented. The CCW logo is still being digitally updated. The new website is up. CCW would like each unit to recruit 3 new ANCW members, which Melanie Fowle has done for our unit! Region VI Silent Auction package for ANCW has many great items including several hunting trips: Melanie Fowle – goose hunt, Sheila Bowen – pig hunt, & Deb Cockrell – deer hunt. The auction will be held during the Summer Conference July 13-15th Denver, CO. CCW chose to nominate Candace Cook Peterson for ANCW Educator of Yr., Nadette Raymond Ott for ANCW Outstanding Cattlewoman, & Celeste Settrini for ANCW Promoter. The ANCW Region VI meeting



was held in April in New Mexico. The border crossing was toured. Approximately 500,000 head of cattle come from Mexico into the US per year. The 2017 Region VI ANCW Meeting will be held in Nevada. CCW Powder River panels raffle tickets are on sale now and each unit that sells tickets gets to keep 50% of the total they sell as a unit fundraiser. The winner will be drawn during the CCW Convention December 1-3, 2016. The CCW Beef Ambassador Contest was held in April. CCW's 2016-2017 Senior Beef Ambassadors are: Joran Somervill – Northern Region from Placer Nevada County, Alyssa Mondani - Central Region from Amador, El Dorado, Sacramento Counties , & Tanya Enlow – Southern Region from San Diego County . CCW's 2016-2017 Junior Beef Ambassadors are: Adam Blalock – Northern Region from Shasta County, Ashley Mayberry - Central Region from Alameda County , & Samantha Carver – Southern Region from Kern County. CCW will be celebrating its 65th Anniversary at the

December 2016 Convention. Plans include video & picture collages, commemorative belt buckles, local unit presentation board showcasing its past, present, & future activities, and a time capsule that will be opened at the 75th Anniversary. The CCW scrapbook contest was been simplified & the updated forms will be posted on the CCW website. Bayer is still sponsoring the contest with \$750.00 is prize money. Alicia Bowen provided a Legislative update. The most notable was the US Supreme Court upheld landowners rights to challenge the WOTUS Jurisdiction on their property. Nancy Hawkins reported on the 2016 CCW Memorial scholarship recipients: Nathan Yerian from Fresno State, Ciara Babcock from Chico State, Katie Carroll from open division, Emily Andreini from UC Davis, & Brooke Niederhauser from Cal Poly SLO. CCW's new officers will be installed at the December 2016 Convention: President – Cheryl Foster, 1st Vice President - Rebecca Been, 2nd Vice President – Jill Bright, Secretary – Tara Porterfield, Treasurer – Melody Lake. Leslie Joost & Deb Cockrell still remain as 2nd Vice Presidents. Michele Murphy will be the membership chair.
