



SPRING CCW MEETING AT HARRIS RANCH HIGHLIGHTS: STORY BY HEIDY CARVER

Eight members of from Siskiyou County CattleWomen (Cheryl Foster, Sharon Erickson, Tara Porterfield, Carolyn Houghton, Rita March, Lori March, Brit March, and Heidy Carver) attended the Spring CCW Meeting on March 11-13th. After a long drive to Harris Ranch in Coalinga, CA on Friday, we enjoyed a great tour of the Harris Farms thoroughbred horse racing farm thanks to Rita March, Kc Jeffery at Harris Ranch, and Dave McGlothlin General Manager of Harris Farms. The tour included meeting Lucky Pulpit - the sire of

California Chrome (pictured to right). Then we had an amazing dinner at the Harris Ranch Steakhouse and enjoyed very nice accommodations at their hotel.

Saturday was a joint California Women for Ag & California CattleWomen meeting filled with a host of informative speakers. First was California FFA member Ethan Francis, who spoke about the false reports that red meat is a significant cause of cancer. His speech was very informative.

Next Kevin Spafford from Legacy by Design spoke about the importance of Succession Planning for agricultural families in order to be able to continue keeping the family farm/ranch operating from generation to generation.



Statistics say that approximately 70% of agriculture businesses are not passed down from the first generation to the second generation, 90% are not passed from second to third, and 96% are not passed from third to fourth generation. Succession planning is the first step and estate planning is the second step in order to ensure that the family ranch/farm is properly passed from generation to generation and still is a viable livelihood. Taking the first step of gathering all the family members and discussing the succession plan is the most difficult due to the emotions of all people involved. The key to a good plan is for there to be open and honest communication between

the family members and that all members are committed to the process. Each succession planning meeting should have "ground rules" and an agenda. There should be an unbiased third party to document each meeting. A succession plan has four parts: Financial security, Ownership transition, Leadership Development, and Estate Plan. Obstacles that hamper a succession plan are: equal vs. fair inheritance, In-Laws, Control of Farm being passed down, financial insecurity, and family disharmony. The goals of a succession plan is to provide operational strength for the farm/ranch, financial security for all family members, and allow the farm/ranch to be well prepared to continue for


generations to come.

The next speaker of the day was Jill Scofield from CA Beef Council. She spoke about how producers need to educate the consumers about where their food comes from, how produced, and how it is processed. Food safety, price value, and food quality are important to the Millennial consumers, who are between ages 18-36 and rely on the internet and social media for their information about agriculture. The Millennials are very diverse in their food types. Their annual income ranges from \$25,000 to \$50,000 and they spend 80% more on food than the Baby Boomer consumers. Their choice of shopping locations is warehouse chain stores and they like to pair their food products together to create an easy to prepare meal.

The final speaker before lunch was CA Secretary of Agriculture Karen Ross, who is a fourth generation farmer from western Nebraska. She was appointed in 2012. There are currently 16 women Ag Commissioners in California. She promoted CA Ag plates through DMV as it raises \$250,000 per year for Ag Industry groups. California has one of the most diverse food consumers and producers, which makes it one of the most studied states. When Ag producers try to educate the consumers, there needs to be open conversations that start with common ground of safe and healthy food. She knows how hard the 5 year drought has been on Ag producers and that most cannot just downsized one year and then



bounce back to full production the next. She understands how intertwined the Ag industry is with the rest of the economy such as entertainment, tourism, and real estate. CA government is trying to conserve Ag land and open space and understand that Ag use is an effective beneficial stewardship of land that promotes self-sustainability while providing food for rest of society.

At lunch we enjoyed a delicious tri tip sandwich with fruit side or a flank steak fajita salad with drink and a lemon bar dessert. The first afternoon speaker was Mike Wade from CA Farm Water Coalition, which is a group that educates the public on the amount of water needed to grow/process various agricultural products and why it is important that the agricultural producers receive the needed water. They use the internet and social media to educate.

The final speaker of the day was Emily Rooney from Ag Council of California, which began in 1919 and is Ag Producer funded by membership dues. California is currently 44% Democrat, 27% Republican, and 29% Independent/Undeclared according voter registration. So need to target the Independent/Undeclared portion of voters when an Ag issue is on the ballot or before the CA legislation.

Government and environmental regulations are becoming an increasing burden for all types of Ag production. CA Environmental Protection Agency, which consists of Air Board, Health & Safety, and Water Board, are all fee based agencies that are hurting agriculture. These agencies do not have much common sense when it comes to efficiently operating a business. California's Sustainable Groundwater Management Act (SGMA) is one of the greater concerns in the Ag industry. It empowers local agencies to adopt groundwater management plans that are tailored to the resources and needs of their communities. Good groundwater management will provide a buffer against drought and climate change, and contribute to reliable water supplies regardless of weather patterns. California depends on groundwater for a major portion of its annual water supply, and sustainable groundwater management is essential to a reliable and resilient water system. However, due to the diversity

within the state and the fact that Agriculture is not always considered an important water user, it is critical that all types of Ag producers and organizations work together to make sure their voice is heard in this process. SGMA is currently in the early stages of being implemented. The day ended with a networking session among all of the attendees. Then a delicious dinner of Fajitas, salads, and desserts was served.

Sunday, the CCW held their Board of Director's Meeting. There were 67 CattleWomen in attendance. The Fiscal Year Ending 10/31/15 financial reporting went well and has been submitted to the CPA per treasurer's report. A neat video was shown highlighting the various events that the CattleWomen units were involved in since the November 2015 Convention.

A recap of the ANCW convention in San Diego at the end of January was given. Highlights were inspirational speaker former Navy Seal Rob O'Neil, trade show, USS Midway ship tour, and Martina McBride concert. The collegiate reception was well attended & they are an enthusiastic group who are working hard to promote Agriculture. ANCW will not change its name or logo.

The Tulare Ag Expo was well attended and the trivia wheel and WOW that Cow app were a hit. Nominees for next year's CCW Officer Team and Standing Committees will be voted on at Mid Year Meeting in June 2016 and they will be installed at December 2016 Convention. CCW would like to increase its ANCW members approx. 100 by January 31, 2017, especially focusing on youth, collegiate, and delinquent members. CCW wants to increase its membership to 2,000 members by September 2016. CCW Beef Ambassador Contest will be held April 9, 2016 in San Jose, CA. There will be 3 Senior winners, one in each of the 3 Regions (North, Central, & South) and 3 Junior winners, one in each of the regions. The winners will work in teams within their regions during the year. The Powder River raffle tickets were handed out - 1500 tickets were printed. New this year - county units will receive 50% of the monies raised from tickets they sell. The Powder River chute that CCW received for winning the ANCW Wiggy contest can be exchanged for more panels or other items. This will be discussed and voted on at the Mid Year Meeting in June 2016. The CCA would like CCW to help with their annual photo contest at December 2016 Convention. It is free to enter pictures. Remember to use high quality settings when taking the picture and emailing it to Malorie Bankhead at CCA. Deadline is October 2016. After some discussion, CCW members approved to have the CCW logo digitally designed so it is more user friendly for internet, social media, and banners. A committee was created and their suggestions will be presented at 2016 Mid Year Meeting. The CCW website is being redesigned to be more user friendly & smartphone compatible. It is expected to be completed soon. Also CCW now owns all the domain rights to its webpage and any similar webpage names. All of the required reporting forms, calendar of events, change of address/email form, and county unit membership forms will be on the new website. The CCW Cowbelle of Year application will be available at Mid Year in June 2016, and due in Sept. 2016 along with current rosters of CCW members.

California Chrome Tied for Top Spot in World

California Chrome, who easily won the world's richest race this year when registering a 3 3 4-length victory despite his saddle slipping in the Dubai World Cup sponsored by Emirates Airline (UAE-I) March 26 at Meydan, shares the top spot in the April edition of the Longines World's Best Racehorse Rankings.

California Chrome, the 2014 Horse of the Year who has won all three of this starts this year, has received a 126 rating, which also was awarded to Winx, who stayed undefeated in seven Southern Hemisphere starts this season with her two-length victory in the Star Doncaster Mile (Aus-I) April 2 at Royal Randwick.
