The SCCA/SCCW Fall Dinner will be held October 27, 2018 in Yreka and the committees have the details handled. CCA/CCW Convention November 28-30th, 2018 in Sparks, NV will be well attended by Siskiyou County CattleWomen to wish Cheryl Foster well as she is outgoing CCW President while Tara Porterfield as Secretary, Heidy Carver as Treasurer, and Sharon Erickson as Northern Director will be installed as part of the 2019-2020 CCW Officer Team.

67TH CCW ANNUAL CONVENTION HIGHLIGHTS: STORY BY HEIDY CARVER

Weather was cooperative for driving to Sparks, NV for the convention, held Nov. 28-30, 2018. A total of 16 Siskiyou County CattleWomen attended. All of us enjoyed spending time with our travels buddies/roommates which made the miles go by quickly. The Convention began with the CCA Opening Session by Dave Daley, which included 2018 Year in review. The highlights were the creation of the Cal Public Lands Council to promote communication between grazing permittees and government agencies and SB 965 approved by Governor Brown which will allow cattle producers to vote on whether to create a California Cattle Council to provide education and research of live cattle issues. Next, Tim Williams from Dept of Interior in Washington DC as a liason to all the environmental, agricultural, and natural resources groups, spoke on revamping National Parks and Wildlife Refuges, promoting hunting and fishing, and multi-use recreation in wilderness and forests. The Dept of Interior is trying to make the environmental regulations and reports more common sense based and require the various other government agencies involved to work together and share information. It also wants to streamline the Endangered Species Act and decrease the amount of sue & settle lawsuits that are used now

to go around Congress. Next Kevin Kester, President NCBA (from CA), shared recent updates on trade, legal issues, and regulations that affect agriculture. He started out thanking California for being one of the top states with 60% of its CCA members also belonging to NCBA. Beef trade with other countries is continuing with new trade agreements. One fifth of US beef is exported to

Asia. The Farm Bill is almost finalized and should be ready by end of 2018. The electronic logbook device regulations affecting livestock transport should be waived for livestock haulers for the foreseeable future. WOTUS is being redefined with clearer and reasonable wording. Country of Origin for food products is continuing. Fake meat production, labeling, and advertising is still a concern and needs to be addressed at a Federal level.

The CCW Executive

Meeting was held Wednesday evening with approximately 20 people attending. Details for Friday's Board Meeting were finalized. Wednesday evening ended with the Allied Industry Reception and trade show. There was good food, drinks, and a lot of neat items at the trade show. The CCW booth did well. Thank you to all who helped managing it.

Thursday began with the CCW President's Training Breakfast. After a little issue with the location, the meeting was well attended. Unit Presidents were given flash drives with updated 2019-2020 forms and directory of CCW Officers/ Committee Chairs. All of the committee chairs stressed the importance of reporting by the deadlines in order for accurate numbers to be gathered. The outgoing officers and committee chairs introduced the incoming officers and committee chairs along with any changes being made in 2019-2020.

Next was the Heritage Foundation meeting, which was attended by approximately 20 people. The 501c3 foundation elected 2019-2020 officers and are in the process of creating/updating their Bylaws/Policies & Procedures. The updated Foundation informational tri-fold brochure was approved. CCW will provide a link within their web page to promote the Heritage Foundation. Funds donated to the Foundation can be used for beef promotion education, leadership education, scholarships, or other items as designated by the donor.

67TH CCW ANNUAL CONVENTION HIGHLIGHTS: CONTINUED

The Cowbelle of the Year Luncheon provided a nice break from meetings. Approximately 120 people attended to honor the 25 recipients. The CCW Education Workshop was in the afternoon. Gary Olsen from Farm Credit spoke on the various lending options available to agriculture and how the internet has affected his business. He said that accrual basis accounting provides the most accurate financial statements. Loans are not just based on collateral. He stressed the importance of proper estate/succession planning. Limited Liability Companies and Limited Partnerships are now on of the most common types of business structures. The average agricultural loan is now \$50-100 million.

Next Susan Menges and Staci Emm spoke

on beef promotion and advocacy that can be done as an individual. The key is to build a personal relationship with the person we are trying to educate. They promoted the "30 second elevator speech" in order to provide the key facts of your topic to your target audience. They provided tips on how to conduct live and phone interviews so that you can have the most control of the topics and interview path. They explained the benefits and drawbacks of using social media. The workshop ended with a short presentation from Seth Joel and Charlie Holland who are photographers who would like to do a California Ranch Raised Kids photo book, including a one-page interview for each child included in the book, with the help of CCW. They have done a book for the Arizona CattleWomen what was very well received and was a good educational fundraising tool. The books sold for approximately \$28 and 1,000 were printed. CCW will discuss supporting the book and it should be complete by December 2019.

The CCW President's Reception in Cheryl's suite was very nice with approximately 30 people visiting and enjoying drinks and snacks provided by Siskiyou and Shasta Counties. The day ended with the CCA/CCW Banquet dinner, which was well attended.

Friday began with the CCW Awards Breakfast. ANCW President Gwen Geis was the guest speaker on current ANCW events/topics. She also promoted Women in Ranching Education and Development (WIRED), which is a new workshop to inform women on ag issues, ranch life workings, and marketing techniques. CCW Awards were given out, and Siskiyou County did very well - *see summary of awards on page 5*. Then CCW honored its nominees for ANCW: Outstanding Beef Promoter which was Maxine DeCosta, CattleWoman of Year – Sheila Bowen, and Outstanding Educator – Pat Shepherd. Pat Shepherd also won the ANCW Outstanding Educator Award. At the end, Gwen Geis and Melanie Fowle inducted the 2019-2020 CCW Officers and Committee Chairs and handed out the customary golden poppies. Congratulations to Siskiyou members who are serving on the CCW board under President Callie Borror: Tara Porterfield – Secretary, Heidy Carver – Treasurer, Sharon Erickson – Northern Director, Cheryl Foster – Past President, and Emma Morris – Beef Promo Chair.

The convention ended with the CCW Board Meeting with approximately 90 attendees. CCW is in the running for the ANCW MOOVE membership contest with almost 2% increase in membership from November 2017 to November 2018. CCW has 179 members who belong to ANCW. The Powder River Panel raffle raised approximately \$21,000 with 50% of the proceeds going back to the units based on their tickets sales. Siskiyou sold approximately \$7,400 in a large part due to Rita March's "sugar daddies". The CCW trade show booth did well with sales of approximately \$1,800 net. The money will be disbursed back to the six local units who sold items at the booth. CCW raised approximately \$2,500 for the Camp Fire relief. It was approved that the Butte County CattleWomen distribute the funds to individuals or groups in the area. The California Ranch Kids book was approved by CCW along with donating \$2,500 to the project. Julie Barnett will be the committee chair. A sheet was passed around for local units to sign up if interested. *See the CCW Calendar of Events on page 4 of this newsletter for all the 2019 meeting dates!*
