

#### **CCW ANNUAL CONVENTION HIGHLIGHTS:** STORY BY HEIDY CARVER

A total of 18 Siskiyou County Cattlewomen attended the annual convention at the John Ascuaga's Nuggett on Nov 19-21, 2015. On Thursday evening, some of us attended the CCW Executive Committee Meeting. The meeting was very informative. Treasurer's report given and CCW is doing well. The 2015/2016 budget was approved. The Powder River panel raffle is going well. Next year the raffle proceeds will be split 50 percent to CCW and 50 percent to the local unit for the tickets they sell, so it will be a fundraiser for all participating units. CCW won the ANCW Wiggy contest and will receive a Powder River calf chute to use as a fundraising tool for 2016. ANCW will most likely be changing its name to ACW in early 2016 if approved at January meeting. Their new website is online and has lots of consumer information. ACW membership drive year is Oct 1 – Sept 30. The 2016 State Beef Ambassador contest will be held in April in San Jose, CA. Each of the CCW regions will have a Senior and Junior Beef Ambassador for a total of 6 beef ambassadors for California. There will no longer be a national Beef Ambassador contest.

Friday was a busy day with many overlapping meetings and workshops. There

was a CCW President's Breakfast where there were many great ideas on how to efficiently operate local units as president. The Cattleman's Breakfast had a guest speaker named Damien Schiff from Pacific Legal Foundation regarding the current legal status of the Water of the United States (WOTUS). Currently an injunction has been filed and accepted that stops the current WOTUS regulations created by EPA and Army Corps from being enacted nationwide. This injunction is up for review in Dec 2015 or January 2016. Next was the Cattleman's General Session with guest speaker Cameron Bruett from JBS USA (a meat processing plant) who spoke about the current meat marketing and sustainability issues facing the cattle industry such as environmentalist and PETA type organizations that have "brainwashed" the consumers into believing



that meat is bad due to unfair animal treatment and being treated with antibiotics. For the meat industry, sustainability is meeting current needs and always being willing to improve the future. It involves a balance of economic, social, and environmental needs. Other speakers on Friday were Erin Borror of the US Meat Export Federation, Colin Woodall from NCBA, Tracy Brunner NCBA President Elect, and Helene Dillard from UC Davis.

Next was the Cowbelle Luncheon honoring the 2015 Cowbelles of the Year, including our own Heidi Martin. Guest speaker was ANCW President Melanie Fowle who spoke about the proposed name change to ACW, new website, and the changes ANCW has made in order to operate more efficiently. Friday afternoon was the CCW Education Workshop, which focused on "Team '16 Going Strong in our 65<sup>th</sup> Year". Guest speaker Justin Oldfield (State Lobbyist) gave an update on SB 27 about antibiotic use and reporting that goes into effect January 2018.

Fowle, Dina Moore, and Connie Watson received Common Thread awards. ANCW CattleWoman of Year is Judy Ahmann. ANCW Promoter of Year is Glenda Rankin. ANCW Educator of Year is Barbara O'Connell. ANCW National Junior Beef Ambassador is Angelee Dowling. Siskiyou County CattleWomen did well. Our scrapbook placed 1st in the 100+ member category. Lynda Beverlin was 5th in the All Star Reading Hours for Ag in the Classroom, and we received a \$50.00 gift certificate for participating in the Walt Rodman contest. The CCW convention ended with the Board of Director's Meeting with approx. 80 members attending. All local units turned in their 2016 Membership information & dues on time for approx. \$30,000. #### CCA NEWS NOTES: Water Board Receives Feedback on SB 88 Emergency Regulation

On Dec. 17, 2015, the State Water Resources Control Board (SWRCB) took public comment on draft emergency regulations intended to implement SB 88's requirements for measuring and reporting of water diversions. The draft emergency regulations, released on December 7, 2015 are available online.

SB 88 was passed as budget trailer language in the 2015-16 California Budget. SB 88, which had been strongly opposed by CCA, requires water diverters who divert over 10 acre-feet of water annually to install monitoring devices that have the capability to record the direct rate of diversion. SB 88 also requires that all water rights holders report annually on their diversion and use of water. This is a significant change for statement and registration holders, who had previously only been required to report every three and five years, respectively.

The SWRCB's proposed monitoring and reporting requirements are on a "phased" approach, and take into account the volume of water diverted. For a full

#### Current News Notes from California Cattlemen's Assn as of 1/8/16

### CDFW Accepting Feedback on Draft Wolf Management Plan

On Dec. 2, 2015 the California Department of Fish and Wildlife (CDFW) released its Draft Conservation Plan for Gray Wolves in California (Wolf Management Plan). CDFW developed its Wolf Management Plan with the input of a diverse Stakeholder Working Group composed of environmental groups, hunting organizations and agricultural interests, including CCA, over the course of roughly two years.

CCA encourages members to review the Wolf Management Plan, available online (see link below) and to provide any comments prior to the Feb. 15 comment deadline. CDFW will also hold three public workshops on the plan, including one in YREKA:

\* Jan. 21 from 5-8 p.m. at the Miner's Inn Convention Center/ Best Western in Yreka

While CDFW is not required to do a full Response to Comments, CDFW Director Charlton Bonham has stated that CDFW will carefully consider public comments received on the draft and may incorporate public comment in finalizing the Wolf Management Plan.

CCA staff is carefully examining the Wolf Management Plan prior to the Feb. 15 public comment deadline and will provide detailed comments to CDFW.

California Sees First
Probable Wolf Depredation

On Dec. 18, the California Department of Fish and Wildlife (CDFW) issued its investigation report for a suspected wolf depredation upon a calf that occurred in Siskiyou County. While the report did not confirm that wolves killed the calf because "the absence of the majority of the carcass... precludes determination of a cause of death," CDFW did classify the depredation as "probable."

Ranchers in Siskiyou County were gathering cattle on the morning of Nov. 10 when they came upon five wolves feeding on a dead calf in a meadow. The wolves dispersed as the ranchers approached, but the ranchers managed to photograph at least one of the wolves as well as the calf carcass upon which the wolves had been feeding. Unfortunately, when investigators from CDFW and USDA Wildlife Services arrived onsite to investigate the suspected depredation, they were unable to locate the calf carcass.

The probable calf depredation and other reports of wolf presence near cattle come alarmingly close to the Aug. 2015 announcement that a wolf pack had first become established in California, and underscore the threat that an unmanaged wolf population could pose to livestock and ranchers in the state.

In response to depredation concerns, CDFW recently released a Wolf Depredation Protocol for Livestock Producers in an effort to ensure that potential depredation evidence is preserved and properly investigated by CDFW, USDA/ APHIS Wildlife Services, and the US Fish and Wildlife Service. New Federal Dietary
Guidelines Finalized:
Includes Lean Beef as an
Important Protein

This week, the U.S. Department of Agriculture and the U.S. Department of Health and Human Services published federal dietary guidelines that are updated every five years and serve as the recommended nutrition guidelines for the nation and dictate menu items for federal meal programs, including school lunch programs.

CCA applauds both agencies for finalizing dietary guidelines that recognize the importance of lean beef as an important protein and part of a healthy balanced diet. An advisory group formed to provide guidance to the Secretaries of Agriculture and Health and Human Services originally suggested that red meat be discouraged as part of a healthy diet due to unsubstantiated environmental concerns. After strong pushback by NCBA, CCA and Congress, the Administration noted that final dietary auidelines would focus on health and nutrition and the suggestions given by the advisory group fell outside the scope of the dietary quidelines.

Since the first dietary guidelines were published in 1990, lean beef has beef has been considered an important and healthy protein and part of an overall balanced diet. CCA will remain active in working to advocate the most current and best science that continues to demonstrate that lean beef is healthy and should remain at the center of the plate.
